Memorandum of Understanding

Between

Shri Bhawani Niketan PG College, Sikar Road, Jaipur

And

Shri Mahaveer College, Jaipur

Purpose: This Memorandum of Understanding (MoU) sets forth the terms and understanding between the Shri Bhawani Niketan PG College, Sikar Road, Jaipur and Shri Mahaveer College, Jaipur to establish a student and faculty exchange program.

- 1. Objective: The primary objective of this MoU is to enhance educational and professional development opportunities for students and faculty members through the exchange of knowledge, culture, and expertise.
- 2. Scope of Collaboration: Both parties agree to collaborate in the following areas:
- a. Student Exchange Program: Facilitate the exchange of students between the two institutions for a period ranging from one semester to one academic year. - b. Shri Mahaveer College Responsibilities: Identify and nominate students and faculty members for the exchange program. Provide necessary logistical support, including accommodation and local transportation, to visiting students and faculty members. Ensure the academic and social integration of exchange students and faculty into the institution.

4. Selection Process:

 Both parties agree to establish a joint committee to oversee the selection process for the exchange program. The selection committee will evaluate candidates based on academic performance, professional experience, and potential for contribution to the host institution.

5. Funding:

- Both parties agree to explore funding opportunities and may seek financial support from sponsors, grants, or other sources to cover the costs associated with the exchange program.
- · Each party will bear its own costs unless otherwise agreed upon.

6. Duration:

This MoU will be effective from the date of signing and will remain in force for a
period of three years. It may be renewed or amended upon mutual agreement of both
parties.

7. Termination:

 Either party may terminate this MoU with a written notice of 30 days. In the event of termination, both parties agree to complete any ongoing activities and settle any outstanding obligations.

9. Dispute Resolution:

 Any disputes arising from this MoU will be resolved amicably through mutual discussion. If a resolution cannot be reached, the matter will be referred to the higher authorities of both institutions.
